Renewable Energy Grants - Businesses



Depending on a number of criteria, Scottish businesses may be eligible to receive funding towards the costs of installing renewable energy technology. In addition to several government led initiatives which provide direct funding assistance, businesses could also qualify for both tax and Climate Change Levy exemptions which would result in further financial savings.

As well as investigating the various routes to funding outlined in this factsheet, it would be advisable to check with your local council and enterprise company to ascertain whether funding could be accessed at a local level.

The Low Carbon Buildings Programme (LCBP)

The LCBP aims to demonstrate how energy efficiency and renewable energy can work hand in hand to create low carbon buildings.

Scottish businesses are potentially eligible to receive funding under Phase 1 of the scheme which allows for a maximum grant of 40-50% of the total installed costs of the technology to a maximum of £100k.

Technologies eligible for funding under the scheme include;

- Solar photovoltaics
- Wind turbines
- Small hydro
- Solar thermal hot water



- Ground/water/air source heat pumps
- Bio-energy

To apply for LCBP funding it is first necessary to preregister (form is available via the link at the end of factsheet). A funding application form will then be sent to you along with a deadline for its completion.

Applications will be assessed every quarter.

Businesses

The Scottish Biomass Support Scheme

The Scottish Executive is keen to promote the level of biomass usage in Scotland and has introduced a support scheme aimed at boosting the development of the industry.

Grants are available to a wide range of businesses considering a biomass installation. The scheme is Scotland wide with total funding of £7.5 million to be spent over the financial years 2006/07 and 2007/08.

The application process for 2006/2007 has now closed, but may reopen in the future.

Enhanced Capital Allowance

The Enhanced Capital Allowance (ECA) scheme is a key part of the UK Government's programme to manage climate change. It provides businesses with enhanced tax relief for investments in equipment that meets certain energy-saving criteria.

Under the scheme businesses can write off the whole of the capital cost of their investment in these technologies against their taxable profits of the period during which they make the investment.

Elegible renewable energy technologies include:

- Biomass boilers and stoves
- Heat pumps
- Solar thermal systems

ECA claims should be submitted as part of your normal corporate or income tax return.

Loan Action Scotland

Through Loan Action Scotland Scottish Small to Medium sized Enterprises (SMEs) can apply for interest free loans ranging from £5,000 to £100,000 to assist with the capital costs of installing certain renewable energy technologies.

As these loans accrue no interest and have no arrangement fee, what you borrow is what you repay. Loans can be repaid over a period of up to 4 years with the aim of being "capital neutral" - the savings from the new

energy saving equipment will cover the cost of repayments.
